Once probation is over, the probationer is no longer required to comply with the terms of probation. If you're unsure of the details of your probation, feel free to ask your attorney or probation officer for help. Some probationers can apply for an early termination of their probation. When deciding whether or not to grant an early termination, the court will consider many factors, including the nature of the probationer's crime and his compliance with the terms of probation.

What Happens After You Complete Probation?

If the last date of your probation has passed, you are off. You will get a letter in the mail to confirm that you are off but unless they file a motion to revoke your probation during the time your probation is active (and based on what you state, there is no reason to do so), then your probation terminates on the date originally stated in your papers.

Generally, the period of probation will not end unless and until you have completed every condition of your probation. For example, your probation will not finish on the scheduled termination date if fines and costs are outstanding or if you have not yet finished the recommended counseling treatment or community service hours.

The general rule I tell my clients is the earliest time to file a request to get off probation should be after you completed at least 50% of your probation term. For example, if you were ordered to a 1-year probation, you should wait until at least the 6-month mark. Be prepared to answer questions from the judge.

You cannot get off federal probation early unless you've paid any monetary amounts assessed to you. Some judges are willing to grant early termination even if you still owe money, provided you've made all payments as scheduled during your supervised release.
